

# Terms & Conditions for "Refer a Friend" Program

# A. Introduction

- "Refer a Friend" (hereinafter the "Program") is a referral program open to clients and partners of Forex4you and Share4you (hereinafter – the "Clients" or the "Client") to refer new Clients (hereinafter - "Friends") to the platform, using a referral link (hereinafter - the "Referral Link") generated in a personal Trader Room or Forex4you mobile application.
- 2. The Client and the Friend will each be rewarded with a USD 50 bonus, when the Friend fulfils the Program's requirements.
- 3. Each Client can receive a USD 50 bonus for every successful Friend referred.
- 4. The Client can check personal progress, i.e., Friend's trading volume and deposits, for the Program at any time by viewing the Client's Trader Room widget (Dashboard).

### **B.** Participation in Program

- 1. Clients who meet the following criteria are able to participate in the Program:
  - a. a Client must be a citizen of and reside in any of these countries: Thailand, Laos, Vietnam, Malaysia, Indonesia, India, Philippines, Nigeria.
  - b. Client's Trader Room must be verified.
  - a Client must be registered for at least one (1) month, must have made a minimum deposit in an amount of USD 100 and traded a minimum volume of 0.5 lots for at least 5 minutes 5 minutes MTT (Minimum Trading Time).
  - d. The Client must have accepted all the Terms & Conditions of the Program.
- 2. To participate as a Friend in the Program, the participant must meet the following criteria:
  - a. Register for an account using a Referral Link and have his/her identity and address verified by Forex4you through his/her account.
  - b. Make a minimum deposit in the amount of USD 500 and trade a minimum volume of 10 standard lots from Forex4you mobile app, Forex4you WebTrader, Forex4you MT4 Trader, Forex4you Desktop, or Share4you.
- 3. The Friend consents to having his or her name and status of successfully signing up under the Program disclosed to the Client.
- 4. A Friend is not eligible to participate in the Program unless the Friend has registered using a Referral link or referral code. When registering, a Friend must ensure unique raffid code is included with the URL address (for example, Referral link: https://account.forex4you.com/en/user-registration/?raffid=rf:Jcb6vk9, referral code: raffid=rf:Jcb6vk9)
- 5. In the event of a dispute over a Client's eligibility to participate in the Program, Forex4you decision will be final and binding.
- 6. Intermediaries/Related Parties of Forex4you will not be allowed to participate in the Promotion. If the registered personal details and/or trading information of a participant



corresponds to the registered personal details and/or trading information of another Forex4you account owner, including but not limited to the IP address of the participant, Forex4you reserves the right to disqualify the participant from participating in the Promotion. For the purposes hereof, the term "Intermediary(ies)/Related Party(ies)", when used in these Terms & Conditions (the "T&Cs"), unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant of the Promotion, including, without limitation:

a) Family members, such as brothers, sisters and spouses;

b) Any person or entity, whom any participant of the Promotion, directly or indirectly through one or more intermediaries, controls (as an owner, beneficiary, trustee or similar), or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the Promotion.

#### C. Program Period

1. On an ongoing basis, starting from **19<sup>th</sup> July 2021**.

### D. General Terms

#### Trading Terms

- The Client and the Friend are entitled to receive a bonus payout (hereinafter the "Bonus Payout") if the Friend meets the following trading terms (hereinafter - the "Trading Terms"):
  - a. Minimum deposit of USD 500 in the trading account.
  - b. Minimum total traded volume of 10 standard lots.
  - c. Held 10 lots of trades for at least 5 minutes 5 minutes MTT (Minimum Trading Time).
- 2. Transfers of funds between Clients will not be considered deposits for the purpose of this Program and will not qualify for a Bonus Payout.
- 3. Only trading accounts that fulfil the deposit and traded volume criteria will be considered for the Program.
- 4. Calculations of the total deposit amount from trading platforms and the total lot volume traded are made from closed orders during the Program period.
- 5. Hedged orders are taken into account in their total full lot volume only in the event where the second order (opposite direction order) was opened not earlier than in three (3) hours after the first one had been opened. Should a period between opening two oppositely directed orders be equal or less than three (3) hours, the smaller order's volume would be counted in the calculations.
- 6. Deposit Bonus funds and lots traded on other bonus funds will not be counted towards the Client's participation in the Program.



# **The Referral Link**

- 1. The Client confirms that Friends who have received the Referral Link for the Program:
  - a. Consent to receive the Referral Link; and
  - b. Are older than 18 years of age.
- The Client hereby acknowledges and understands that the Client must not distribute the Referral Link to any Friend who is a citizen of and resides in jurisdictions which Forex4you does not offer its services to, as reflected in its official Website (hereinafter - the "Website").
- 3. Referral Links generated via the Forex4you mobile application can only be used for referring Friends through the mobile application. Likewise, Referral Links generated in the Trader Room can only be used for referring Friends through the Website.
- 4. The Client shall not use the Referral Link in any manner that is illegal, disparaging, misleading, obscene, or in any way that is detrimental to Forex4you.
- 5. It is understood that any inappropriate use of the Referral Link may cause immediate termination of the Client's participation in the Program.
- 6. Without prejudice to the foregoing, the Client acknowledges that he/ she remains solely responsible for the usage of the Referral Link and that the distribution of the Referral Link to the Client's Friends is at his/ her full discretion; the Client hereby understands that Forex4you undertakes no responsibility whatsoever for the Client's actions.

# E. Bonus Payout

- 1. Each Client and the Client's particular Friend are entitled to a Bonus Payout only once (1), irrespective of the number of times the Friend fulfils the Trading Terms.
- 2. Both the Client and Friend receive the Bonus Payout of USD 50 from Forex4you when the Trading Terms are fulfilled.
- 3. A Friend will not be eligible for a Bonus Payout if the Friend does not fulfil all the Trading Terms within six (6) months of account registration.
- 4. A Bonus Payout will be made only to Friends and Clients who have fulfilled all the Trading Terms and received approval from Forex4you.
- 5. The Bonus Payout will be paid into the Client's and Friend's Forex4you or Share4you accounts in a weekly payment cycle and will be available for trading or withdrawal purposes.
- 6. The entitlement to the Bonus Payout is not replaceable, refundable, transferrable, or exchangeable for gifts, cash, or benefits in kind. The Bonus Payout will be transferred to an account attached to the Trader Rooms which the Client and Friend have used to participate in the Program.

### F. Reservation of Rights and Disqualifications

# Forex<sub>4you</sub>

- 1. Forex4you reserves the right at its reasonable discretion, to:
  - a. Decline registration to any participant in the Program;
  - b. Disqualify any participant of the Program who violates or abuses the terms of use of Forex4you services.
- 2. Only Clients who have registered with Forex4you and are from the relevant country are eligible to participate in the Program. At any given time, we may ask the participant to provide personally identifiable information. Forex4you reserves the right to limit, block access to its services and/or terminate the Client account if such information is not provided. By providing us with the information and registering with Forex4you, you confirm that any information provided is correct, accurate up to date and complete.
- 3. Forex4you reserves the right, at its reasonable discretion, to discontinue the Program without any prior notification.
- 4. Forex4you reserves the right to alter, amend or terminate the Program, or any aspect of it, at any time. Forex4you is not obliged to warn customers about changes in the Program. The Client is obliged to comply with all the rules and conditions of the Program, as well as monitor changes in the relevant terms and conditions.
- 5. Any indication or suspicion, in Forex4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- 6. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the Program, the Client will not be entitled to any prize. Participants who attempt to abuse the Program or manipulate their position in the Program will forfeit their prize in favor of the next chosen Client in line for the prize. If any participant attempts to compromise the integrity or legitimate operation of the Program by hacking or by cheating or committing fraud or via manipulation in any way, including by providing false details or by false registration, Forex4you may terminate such Client account at its sole discretion. Further, Forex4you may refrain from granting prizes and/or deduct any such prizes' amounts that were given to such participants under the Program and/or ban the Client from participating in any of future draws and other programs.
- 7. These terms & conditions have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
- 8. Forex4you reserves the right to disclose and publish the name, and such other details (including photograph) of any participant/ winner in such mode and manner as Forex4you may at its sole discretion deem appropriate for publicity purposes and the participant/ winner agrees to be photographed, to the disclosure of his or her personal details, the use of his or her name, picture, image and voice for publicity purposes connected with the Program and to cooperate with and participate in the activities organized by Forex4you for this purpose without additional compensation.
- 9. All winners must share news of their award in social media prior to receiving the prize from Forex4you.
