

## TERMS AND CONDITIONS FOR THE “BINGO!” PROMOTION

### 1. INTRODUCTION

1.1. This document describes the terms and conditions of the Bingo! Promotion (the “Promotion”) - a Forex4you marketing promotion.

### 2. PARTICIPATION ELIGIBILITY

2.1. Only new Forex4you Partners who meet the following criteria can participate:

2.1.1. Location/Country of registration: **Malaysia**.

2.1.2. New Forex4you Partners are defined as Forex4you Clients who have an account under the Forex4you Affiliate program, Forex4you IB program or Forex4you Pro-STP markup program and who have registered **from 01 August 2020 onwards**.

2.1.3. Partner’s Clients whose activities are eligible are:

2.1.3.1. All Forex4you Clients under Forex4you IB Partners;

2.1.3.2. All Forex4you Clients under Forex4you Pro-STP Mark-up program Partners;

2.1.3.3. Only trades from direct/1<sup>st</sup> level Clients of the "Affiliate" Partner program will be considered for the Promotion. Trades by Level 2 and/or 3 affiliate Partner Clients are not considered and taken into account for the Promotion.

2.1.4. All Partners must verify their Forex4you accounts.

2.1.5. Forex4you Partner’s Clients must have verified accounts for their trades and deposits to be counted towards relevant Partner’s participation in the Promotion.

2.1.6. There should be no duplicate accounts; Partners should only have one Forex4you Trader room.

2.1.6.1. Partners shall not and are prohibited from using family members and/or close friends to create new Forex4you accounts.

### 3. PERIOD OF PARTICIPATION

3.1. The Promotion trading period runs from **01 October 2020** until **31 December 2020** (the “Promotion trading period”).

### 4. PROMOTION TERMS

#### 4.1. Registration:

4.1.1. Partners will need to register to participate in the Promotion via the official Promotion landing page.

#### 4.2. Minimum Requirements

4.2.1. The Partner must satisfy the following minimum requirements during the Promotion trading period in order to participate in the Promotion:

4.2.1.1. Partner account is registered from **01 August 2020**.

#### 4.3. Bingo Lines

4.3.1. The Promotion is based on the Bingo lines as set out in this Clause 4.3.

4.3.2. If a Partner has reached and is maintaining the minimum requirements for the Promotion, all Partner’s Bingo lines created will be valid.

4.3.3. Each cell in the Bingo card consists of one (1) task that the Partner needs to complete.

4.3.4. When the Partner completed three (3) cells that form a line, the Partner is considered to have completed one (1) Bingo Line.

4.3.5. The Bingo line can be in vertical, horizontal or diagonal.

4.3.6. Examples of Bingo lines:

## 4.3.7. Maximum number of Bingo lines is eight (8).

4.3.8. Calculation of Bingo lines that can be created (only single direction of the Bingo line is taken into account, e.g. a Bingo line going left-to-right and right-to-left is counted as one single Bingo line):

				
				
				
				

4.3.8.1. Line 1,2,3, is Horizontal Bingo line

4.3.8.2. Line 4,5,6 is Vertical Bingo line

4.3.8.3. Line 7,8 is Diagonal Bingo line.

4.3.9. Partners can claim the prize for each Bingo line achieved.

4.3.10. An active Client is defined as a Client who traded one (1) lot during the Promotion trading period.

4.3.11. Total "IN" is defined as total deposits made by the Client during the Promotion trading period.

## 4.4. Tracking of Progress

4.4.1. The Partner may contact Forex4you customer service or key account managers to check their Promotion progress and eligibility.

## 4.5. Rewards (Prizes)

4.5.1. Partners who completed the tasks in three (3) cells that form a Bingo line are eligible to claim a reward (a prize).

4.5.2. Each Bingo line created is allocated one (1) type of prize (the "Line prize"). There are a total of eight (8) Line prizes – the same as the number of Bingo lines.

4.5.3. A Partner can claim only 1 Line prize from each Bingo line.

- 4.5.4. There will be a maximum of 20 (twenty) Partners that can claim a Line prize.
- 4.5.5. When a Partner completed a Bingo line, this Partner needs to contact Customer Support or key account managers to claim the Line prize.
- 4.5.6. The Company is not responsible for informing a Partner when a Bingo line has been completed by this Partner. It is the sole responsibility of the Partner to follow his/her progress in the Promotion.
- 4.5.7. The Line prize is to be claimed on first-come, first-served basis. When the number of Partners claiming a Line prize has reached 20 (twenty), this Line prize is considered fully claimed and no further Line prizes for this particular Bingo line will be granted.
- 4.5.8. If a winning Partner is disqualified, it is at Forex4you's discretion to choose a new Partner to replace the winner.
- 4.5.9. Line prizes are subject to stock availability during the Promotion trading period. If a particular Line prize is not in stock, Forex4you has the right to replace the Line prize with another Line prize. It is at Forex4you discretion to choose the retailer.
- 4.5.10. The list of the Line prizes is as follows:

## 5. LOTS AND ORDERS

- 5.1. Hedged orders are taken into account in their total full lot volume only in the event where the second order (opposite direction order) was opened not earlier than three (3) hours after the first order had been opened. Should the period between the opening of two opposite directed orders, be equal to or less than three (3) hours, the smaller order's volume would be counted in the calculations.
- 5.2. Deposit bonus funds and lots traded using bonus funds (e.g. Deposit Bonus promotion) will not be counted towards the Promotion.
- 5.3. Total traded volume is counted from closed orders at the end of the Promotion trading period. Any orders that are open at the end of the Promotion, will not be considered for the Promotion.
- 5.4. The deposit and traded volumes from all existing trading platforms will be assessed at the end of the Promotion trading period.
- 5.5. All calculations are done on a Trader Room level and not per Individual Partner accounts.
- 5.6. Forex4you will determine the final results of each Partner. Data will be derived from data of Partner's activity, but result from the Promotion will not include:
- 5.6.1. Internal fund transfers;
- 5.6.2. Any other monetary activity that Forex4you deems unfit.

## 6. REWARDS AND AWARDING

### 6.1. Choosing the Winners:

- 6.1.1. Only Partners approved and announced by Forex4you are eligible to claim the Line prize (the reward).
- 6.1.2. By accepting the rewards, the Partners unconditionally consent to these terms and conditions of the Promotion.
- 6.1.3. Forex4you reserves the right to substitute any Partner subsequently found to be ineligible or disqualified. Forex4you's determination of the Partner's results shall be final, conclusive, and binding.

### 6.2. Nature of the Reward

- 6.2.1. Rewards for may differ from those advertised.
- 6.2.2. Forex4you reserves the right to replace and/or substitute and/or change the reward with another item of an equivalent, or close to the prevailing recommended retail price, of any of the rewards, at any time and without giving any prior notice, or reasons, or assuming any liability to any party.
- 6.2.3. The entitlement to the reward is not replaceable or refundable or transferable or exchangeable for gifts, vouchers or cash or benefits-in-kind, unless Forex4you deems it to be.
- 6.2.4. Rewards cannot be transferred to other Partners.

### 6.3. Awarding of the Rewards and Revoking of the Rewards

- 6.3.1. Eligible Partners should initiate the request for the Line prize from Forex4you when they successfully form a Bingo line.
- 6.3.2. After Forex4you receives the request to claim the Line prize from a Partner, Forex4you will respond via a personal call, message or email notifying the claiming Partner of his/her eligibility to receive the Line prize.
- 6.3.3. Should the Partner fail to reply to Forex4you confirmation of the reward within five (5) business days via phone or email, such Partner will forfeit his/her reward, and a new winner will be selected.
- 6.3.4. Forex4you reserves the right to disclose and publish the names, and such other particulars (including photography) of any Partner in such mode and manner as it may at its sole discretion, deem appropriate for publicity purposes. The Partner also agrees to be photographed, to the disclosure of his or her personal information, the use of his or her name, picture, image and voice for publicity purposes connected to the Promotion and to co-operate with and participate in the activities organized by Forex4you for this purpose without additional compensation.
- 6.3.5. All Partners must provide adequate documentation if requested. Failure to provide the documents may result in the Partner forfeiting the reward. If the Partner does not provide documents requested within 10 (ten) working days, Forex4you has the right to revoke the reward.
- 6.3.6. Forex4you excludes all and any liability, for rewards which are lost, delayed or damaged in transit, Proof of postage will be provided upon request. If the reward has been sent out for delivery, it is the responsibility of the Partner to contact the respective courier or delivery company and follow up on the delivery of the rewards.
- 6.3.7. Forex4you does not provide any warranty for the rewards, and all and any warranty/quality claims should be made to the respective reward manufacturers.
- 6.3.8. If Forex4you subsequently discovers or determines in its absolute discretion that a Partner is not entitled to, or is disqualified from participating in the Promotion, or is unable to adhere to any terms and conditions in relation to the Promotion, Forex4you shall, at its sole discretion, decide on the following:
  - 6.3.8.1. Partner of the Promotion to forfeit the reward;

6.3.8.2. and/or re-claim the reward from the Partner and select the next qualifying Partner.

## 7. **RESERVATION OF RIGHTS AND DISQUALIFICATION**

7.1. Forex4you reserves the right at its reasonable discretion, to:

7.1.1. Remove any Partner from the Promotion if such Partner violates or abuses the terms of use of Forex4you's services.

7.1.2. To discontinue the Promotion or these additional conditions without any prior notification.

7.2. Forex4you reserves the right to alter, amend or terminate the Promotion, or any aspect of it, at any time. Forex4you is not obliged to warn Clients and/ or Partner about changes in the Promotion. The Partners are obliged to comply with and monitor relevant changes in these Promotion terms and conditions.

7.3. Only Partners who have registered with Forex4you and are from the relevant countries, are eligible to participate in the Promotion. At any given time, we may ask the Partner to provide personally identifiable information for verification purposes. Forex4you reserves the right to limit, block access to its services and/or terminate a Partner's account if such information is not provided. By providing us with the information and registering with Forex4you, you confirm that any information provided is correct, up to date, and complete.

7.4. If a Partner experiences data integrity issues concerning account statistics and therefore did not qualify for the Promotion, the Partner will not be entitled to any reward. Partners who attempt to abuse the reward Promotion or manipulate their position in the Promotion will forfeit their reward in favor of the next randomly chosen Partner in the Promotion.

7.5. If any Partner attempts to compromise the integrity or the legitimate operation of the Promotion by hacking or by cheating or committing fraud or manipulation in any way, including providing false details or false registrations, Forex4you may terminate such Client accounts at its sole discretion. Further, Forex4you may refrain from granting rewards and/or deduct any such reward amounts that were given to such participant under the Promotion and/or ban the Partner from participating in any of its future Promotions.

7.6. Any indication or suspicion, in Forex4you's reasonable opinion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account related to the Partner activity or this Promotion.

7.7. These terms & conditions have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any discrepancies, the English version shall prevail.
